# Executive Summary

The Serenity Project is an innovative hybrid concept combining luxury hospitality and modern investment through the tokenization of an exclusive 4-star resort in Carinthia, Austria, alongside the development of a diversified digital ecosystem. It merges physical value creation, cutting-edge technology, and contemporary investment mechanisms into a unique project that offers lasting value to both guests and investors.

At its core lies the Serenity Resort – a state-of-the-art lifestyle and wellness destination set in one of Austria's most attractive regions. Spanning over 35,000 m<sup>2</sup>, the resort will feature premium spa areas, club and entertainment zones, hotel suites, fine dining, casino and event facilities, a shooting and sports center, and exclusive hospitality experiences. The resort is not just an operational business but the real, tokenized core asset of the entire Serenity ecosystem. The construction is budgeted at approximately €45 million, establishing the fundamental value anchor of the project.

In parallel, a multi-layered digital ecosystem is being developed to create additional revenue streams and significantly enhance Serenity's economic strength. This ecosystem includes:

- **Serenity Token (SRT):** The digital investment certificate of the entire system, serving as entry access, value carrier, and participation instrument.
- **Serenity Reserve System:** An innovative yield model that transforms tokens, commissions, and participations into ongoing profit distributions.
- **Serenity Exchange:** An internal trading and payment platform for tokens and other digital assets.
- **Trading & Investment Division:** Professional capital management generating daily returns from Forex and selected financial markets.

- **Serenity AI & Digital Solutions:** A modern AI-based communication and content platform that opens up new digital revenue models for users, creators, and guests.
- **E-Commerce & Branding Hub:** A commerce and merchandising concept for both physical and digital products under the Serenity brand.
- **Project Onboardings & Partnerships:** A tokenization and white-label infrastructure through which external brands can launch their own projects on the Serenity Exchange.

By combining real assets + digital revenue streams + tokenization, an investment model with high economic diversification is created. This structure enables income from operational resort profits, digital platform revenues, trading returns, exchange fees, online commerce, partnerships, and other business sectors.

The project's objective is to raise a total of €100 million through various financing phases. This capital will be allocated to land acquisition, resort construction, the development of the technical ecosystem, the exchange infrastructure, marketing, and international expansion. The Serenity Token will be issued within a four-stage offering model, starting at a price of €0.08.

# Legal Structure

The Serenity Project is based on a clearly defined legal framework that ensures transparency, accountability, and professional execution across all business sectors. To represent both the digital and physical components of the project in a legally compliant and efficient manner, Serenity is operated through two independent yet interconnected corporate structures.

## Token & Ecosystem Entity (Georgia)

The entire digital infrastructure of the project – including tokenization, the Serenity Exchange, the Serenity Reserve System, AI & digital platforms, as well as e-commerce and onboarding solutions – is managed through a dedicated project company based in Georgia.

This legal structure provides:

- Clear regulatory frameworks for digital assets,
- Optimal conditions for tokenization, digital services, and technological development,
- International scalability and the ability to connect global partners and projects through the Serenity Exchange.

All token issuances, reserve models, platform operations, and digital business divisions are managed through this Georgian main entity.

# Resort Operating Companies (Austria)

The physical core of the project – the Serenity Resort in Carinthia – is managed through dedicated Austrian subsidiary companies. These entities are responsible for:

- Land acquisition and construction management,
- Hotel and club operations,
- Staffing, management, and infrastructure,
- All operational activities of the resort,
- The resort-generated profits that are distributed to token holders under the Hold Model.

The Austrian and Georgian operating companies are managed by Dirk Palka, who, as CEO, brings many years of international experience in the hospitality and leisure sectors. He is responsible for both the development and the operational management of the resort.

# Market & Initial Situation

## Market for Luxury, Wellness & Lifestyle Resorts

The international market for high-end wellness, lifestyle, and club resorts has been experiencing structural growth for years. Guests with sophisticated expectations are increasingly seeking experiences that go beyond traditional hospitality – places that combine relaxation, discretion, entertainment, and social status within a cohesive overall concept.

### Experience-Oriented Travel Instead of Standard Tourism

Affluent target groups today expect far more than a comfortable room and a spa. They are looking for tailor-made stays featuring curated experiences, entertainment, culinary excellence, and exclusive services that cannot be easily replicated elsewhere.

### Growing Demand for Discreet Concepts

Especially within the premium and high-net-worth segments, there is rising demand for discreet, private hospitality products in which privacy and a controlled environment play a central role. Exclusive clubs, members-only concepts, and hybrid resort formats are gaining increasing importance.

### Combination of Wellness, Lifestyle, and Entertainment

While traditional wellness hotels are well established, the next stage of development lies in combining wellness, nightlife, entertainment, and fine dining. Guests seek to rejuvenate during the day and indulge in the evening – in an environment that is stylish, secure, and consistently branded.

### Europe as a Stable Premium Location

Europe – particularly regions such as Austria, with its strong tourism infrastructure, political stability, and natural beauty – provides an ideal environment for long-term resort investments. Carinthia combines nature, accessibility, and tourism expertise with growing interest in premium lifestyle concepts.

## Tokenization Market

In parallel with developments in the hospitality sector, the market for digital assets and the tokenization of real-world assets has evolved dynamically in recent years. While the first phase of the crypto market was largely dominated by speculative tokens without real backing, the focus is now shifting increasingly toward asset-backed tokens and real-world assets (RWA).

## Key Points of This Development

### Tokenization of Real Assets

Real estate, hotels, infrastructure projects, and other tangible assets are being represented through token models in an increasing number of jurisdictions. The digitization of ownership and participation rights enables fractionalization, global accessibility, and technological automation of investments.

### Fractional Ownership & Accessibility

Traditionally, resort and hotel investments were reserved for institutional investors or very wealthy individuals. Through tokenization, it becomes possible to purchase shares in smaller amounts, providing access to a broader but still qualified investor base.

### Efficient Processing & Transparency

Blockchain technology allows for automated transaction processing, transparent tracking of token movements, and technical mapping of distribution logic. As a result, participation structures can be designed more efficiently, cost-effectively, and transparently than through purely traditional means.

### Combination of Digital Assets & Real Assets

While many traditional cryptocurrencies are purely speculative, the trend for the coming years focuses on hybrid models – digital tokens directly linked to real cash flows, real estate, or operating companies. Serenity positions itself precisely in this segment and aims to take a pioneering role for similar projects in the future.

## Problem & Market Gap

Despite the developments described above, there remains a significant gap between traditional resort investments and modern crypto or token models:

### **High Entry Barriers in Traditional Resort Investments**

Investments in high-quality resorts typically require very high capital commitments, complex contractual structures, and direct access to project developers or institutional vehicles. For most investors, this market remains difficult to access.

### **Lack of Integrated Hybrid Projects**

While there are some tokenized real estate or hotel projects, very few concepts successfully combine:

- A real, clearly defined asset (resort),
- A functioning, diversified ecosystem with multiple revenue streams, and
- A transparent, long-term model for distributions and participation.

### **Missing Connection Between Operations and Token Economy**

Many token projects have only a weak or indirect link to actual revenues. Often, there are no clear mechanisms explaining how operational profits (e.g., from a resort business) are actually reintegrated into the token economy.

### **Unclear or Short-Term Incentive Structures**

In many projects, the focus lies purely on price appreciation, or they feature confusing bonus systems that deter long-term stability and serious investors.

## Serenity as the Solution

Access to high-quality resort investments has traditionally been reserved for large investors – high entry amounts, complex contractual structures, long waiting periods, and external intermediaries such as banks or notaries have made this market practically inaccessible. At the same time, modern crypto projects have offered innovative technologies but rarely any real, tangible value creation.

### **Serenity fundamentally changes this.**

With the Serenity Token (SRT), investors gain, for the first time, a digital investment certificate backed by a real luxury resort – fully managed via blockchain. Each token represents a clearly defined, registered share in a real project, allowing for immediate, transparent, and legally secure participation without bureaucracy, notaries, or waiting times. The entire structure is secured by a smart contract, ensuring absolute traceability and 100% safe transfers.

At the same time, Serenity provides a solution to one of the biggest challenges of traditional real estate and resort investments: the long waiting period before the first returns.

To address this, the Serenity Reserve Model was developed – a system that enables investors to receive regular payouts from the entire ecosystem long before the resort opens. Investors who place their tokens into the reserve give up their permanent participation rights in the resort itself but gain faster and continuous returns from all business sectors.

For long-term investors, the Hold Model remains available: those who hold their tokens retain their official tokenized shares in the physical resort and benefit from its profits for life.

Thus, Serenity offers a solution that no other project has combined in this form before.

### **The core principle is simple:**

One project – multiple income streams.

While the resort, as a physical core asset, provides stable long-term income, the digital business divisions expand the system with additional scalable profit streams. Profits from all divisions then flow into the Serenity Reserve System, which forms the yield base for all investors.

The Serenity Token serves as the central access instrument to the entire ecosystem. It functions as a digital investment certificate that governs participation rights and bonus models while simultaneously providing access to all physical and digital business areas. In this way, the token directly connects the real value creation of the resort with the digital revenue streams of the Serenity system.

### **The ecosystem follows a clear objective:**

# Core Components of the Ecosystem

The Serenity ecosystem consists of several strategically interconnected business divisions that jointly generate revenue, create synergies, and enable distributions to investors. Each component fulfills a specific economic function and strengthens the overall model.

### **Serenity Resort & Club Concept**

At the heart of the Serenity ecosystem lies the planned 4-star luxury resort in Carinthia, combining wellness, lifestyle, gastronomy, and discreet entertainment concepts.

#### **It simultaneously serves as:**

- A real value creation center (revenue from accommodation, spa, gastronomy, club, casino, and events),
- A brand anchor conveying trust, luxury, and exclusivity,
- A participation vehicle for all investors who hold their tokens (HOLD strategy),
- A long-term cash flow source enabling stable distributions.

The resort is the primary project through which investors receive real, tangible, and sustainable returns.

### **Serenity Token (SRT)**

The Serenity Token is not a volatile speculative asset but a tokenized participation certificate with a clearly defined utility.

The token represents:

- The invested amount,
- The right to receive distributions,
- The share in the Serenity Resort (only under HOLD),
- The claim to reserve-based yields (under RESERVE).

All transactions are smart contract-based, tamper-proof, and fully transparent.



## Ecosystem

### Serenity Reserve System

The Serenity Reserve System is the central yield model in which investors can deposit their tokens to receive earlier and more frequent distributions.

#### Mechanism:

- Tokens are permanently locked in the smart contract (“Reserve Status”).
- Investors receive yields from all areas of the ecosystem.
- Every profit generated from the resort, trading, e-commerce, AI platforms, etc., flows proportionally into the Reserve Balances.

### Serenity HOLD Model

- Trading of SRT Tokens at the official fixed Serenity price (only from the HOLD model).

- Stable, blockchain-based escrow processing.
- Trading of additional assets: USDT, BTC, ETH, EUR.
- Deposit and withdrawal system for yields, reserves, and rewards.
- Foundation for new tokenization projects launched through Serenity.

### **The Exchange**

The Exchange serves as the secure financial hub of the entire system. In the long term, it is designed to integrate additional coins, tokens, and digital assets, creating a sustainable and continuously growing trading infrastructure.

### **Trading & Investment Division**

A professionally managed trading branch that actively allocates capital across various markets:

- Forex (main focus),
- Crypto swing strategies,
- Indices and algorithmic systems.

A portion of the deposited capital is allocated to this division. The profits generated here continuously flow into the Treasury and Reserve Pool, thereby accelerating distributions. This provides shorter-term, regular cash flows, while the resort serves as the long-term stability source.

### **Serenity AI & Digital Solutions**

A highly profitable digital asset within the ecosystem: an AI-powered communication, content, and monetization platform.

#### **Features:**

- AI-based communication and chat automations.
- Monetizable premium chats, content paywalls, AI image and video tools.
- Specifically optimized for creators, performers, models, and entertainment industries.
- Recurring revenues (subscriptions, pay-per-use, service fees).
- Upselling systems and microtransaction models.

This platform is a scalable revenue engine that generates continuous digital income for the entire ecosystem.

### **E-Commerce & Branding Hub**

The Branding Hub encompasses all digital and physical commerce models:

- Serenity Merch (fashion, accessories, lifestyle),
- Digital products (memberships, NFTs, access passes),

- Creator merchandising,
- Global online shops (Shopify, Amazon, EU fulfillment).

Every sale generates fees and margins that flow into the Serenity Treasury. The hub creates continuous online revenue streams, independent of the resort's physical location.

### **Project Onboardings & Partnerships**

Serenity also serves as a platform for external projects, which can be tokenized, funded, or operated through the Serenity infrastructure.

#### **Examples:**

- Tokenization of real estate projects,
- Tokenization of creator brands,
- White-label token launches,
- AI-driven monetization projects,
- B2B onboardings.

#### **Revenue Streams:**

- Listing fees,

This component enables additional external capital inflows. Furthermore, through participation in the business divisions of onboarded partners, Serenity establishes ongoing income streams, which are also distributed to participants in the Reserve Strategy, continuously expanding and strengthening the entire ecosystem in all areas.

The Serenity ecosystem is built on a clearly defined, diversified revenue model that consolidates operational profits from multiple independent business divisions. This creates a stable and transparent system that combines real-world value creation with digital income mechanisms.

The yields originate from several core pillars of the Serenity ecosystem. These include revenues from the Serenity Resort (hotel, spa, gastronomy, club, entertainment), profits from the Trading & Investment Division, sales from the E-Commerce & Branding Hub, digital earnings from the AI & Digital Solutions Platform, transaction fees from the Serenity Exchange, participations from Business Onboardings & Partnerships, as well as proceeds from the Serenity App & Innovation Layer.

Through this structure, risk is spread across multiple strong business fields while maintaining a steady cash flow. The combination of real assets and scalable digital models makes Serenity a sustainable, resilient, and long-term growth-oriented ecosystem, forming the foundation for the yields distributed to investors under the Hold or Reserve models.

## Ecosystem Components

# Serenity Resort & Club Concept

**The Serenity Resort** is the central real-asset component of the entire Serenity ecosystem. As the physical core project, it creates real value, stable cash flows, and the foundation for the tokenized participation model. Located in Carinthia, one of Austria's most scenic regions, the project envisions a unique 4-star superior luxury resort that combines wellness, lifestyle, entertainment, and high-end hospitality within an innovative concept.

### Location & Project Scope

The resort will be developed on a property in Carinthia, with land acquisition secured at short notice. The region ranks among the strongest tourism destinations in Central Europe and offers an ideal combination of nature, seasonal diversity, international visitor demand, and excellent transport connectivity. The planned total investment costs for land, construction, and equipment amount to approximately €45 million.

### Strategic Advantages of the Location:

- High tourism demand from Austria, Germany, Italy, and Switzerland.
- Proximity to airports (Klagenfurt, Ljubljana, Salzburg, Venice, Graz).
- Year-round occupancy potential through wellness, events, and leisure offerings.
- Lower construction costs compared to top Alpine regions with equal attractiveness.

Architecturally, the resort will be designed as a modern glass-nature hybrid project – clear, elegant, open, and energy-efficient.

Carinthia is one of Austria's most attractive tourism regions. The location ensures a combination of strong seasonal diversity, excellent infrastructure, and stable demand from visitors across Austria, Germany, Italy, and Switzerland. Its proximity to several international airports (Klagenfurt, Graz, Ljubljana, Venice, Salzburg) enables access to a broad international audience while maintaining a strong domestic and weekend tourism base.



## Ecosystem Components

### Architecture

The planned building complex will include a spacious spa and wellness area, a hotel with at least 60 rooms within the central resort building, as well as an additional business/event hotel with 50–70 rooms, serving as supplementary capacity for online booking platforms. This second hotel wing is deliberately designed to operate independently from the club area, allowing for broad market accessibility without compromising the exclusivity of the main resort.

The architectural style follows a clear premium standard – featuring extensive use of glass, warm natural materials, modern lines, and generous spatial concepts. High-quality interior design, state-of-the-art building technology, energy-efficient systems, and a comprehensive energy management setup (including photovoltaic systems, heat pumps, and energy storage technologies) ensure long-term low operating costs.



## Ecosystem Components

### Concept & Offering

The Serenity Resort combines multiple highly attractive business areas that together create a unique lifestyle experience. The wellness area serves as the central attraction, featuring multiple saunas, steam baths, infrared zones, a salt lounge, as well as indoor and outdoor pools. This area is complemented by private spa suites and a therapeutic regeneration section offering NAD+ treatments, detox programs, and body aesthetics services.

The hotel itself will feature at least 60 premium rooms – ranging from Superior Rooms to Signature Suites. In parallel, a second, independently operated hotel with around 50–70 rooms will be developed for platforms such as Booking.com, significantly increasing the baseline occupancy rate without compromising the exclusivity of the main resort.

Another core component is the club and entertainment area, which includes a central bar lounge, a high-end light and sound system, a show stage, as well as multiple VIP suites and themed rooms that provide guests with a discreet and exclusive environment. This segment targets a high-spending clientele and ensures additional stability through high frequency and strong profit margins.

Culinarily, the resort sets new standards with a fine dining restaurant, private dining rooms, a cigar lounge, and an extensive outdoor lounge, creating a gastronomic experience that appeals to both resort guests and external visitors.

The concept is rounded off by a casino and entertainment zone featuring gaming tables and modern slot machines, as well as a spacious sports and activity area that includes a professional shooting range, padel courts, paintball facilities, and potentially an outdoor go-kart track. In addition, a dedicated event and convention area will be established, featuring conference rooms, meeting spaces, and a large event hall – ideal for concerts, corporate events, lifestyle fairs, and shows.

The Serenity Resort combines multiple revenue sources, resulting in high income stability and attractive profit margins.

For investors participating in the HOLD model, this means direct involvement in the resort's profits through a tokenized, fair, and transparent participation structure. At the same time, the resort strengthens brand credibility, enhances visibility for partner projects, and serves as the cornerstone for scalable international expansion.

# The Serenity Token (SRT)

**The Serenity Token (SRT)** is the central digital element of the Serenity Project – intentionally designed not as a traditional cryptocurrency that is freely traded on public exchanges or subject to speculation. Instead, the SRT functions as a tokenized investment certificate that represents each investor's individual investment amount and transparently records their rights within the Serenity ecosystem.

**Not a Speculative Token, but an Investment Certificate**

The Serenity Token is structured to avoid the typical mechanisms of volatile crypto markets. It is:

- Not a meme token,
- Not a freely fluctuating trading currency,
- Not a speculative asset whose price depends on short-term market trends.

**Instead, the SRT represents:**

- The amount an investor has contributed to the project,
- The right to defined distributions from the Serenity ecosystem,
- Depending on the chosen strategy:
  - A participation claim in the Serenity Resort (HOLD), or
  - A yield claim from the Serenity Reserve (RESERVE).

Thus, the token serves as the digital representation of an investment, not as a risky, externally driven trading asset.

## Token

### **Function Within the Serenity Ecosystem**

The Serenity Token serves as the key to the entire ecosystem. It connects real-world value creation – particularly through the Serenity Resort – with the digital revenue streams from:

- Trading & Investment Division,
- Serenity AI & Digital Solutions,
- E-Commerce & Branding Hub,
- Serenity Exchange,
- Project Onboardings & Partnerships.

Through the SRT, it is clearly defined how and in what form each investor participates in the system. After joining, every investor receives a specific number of Serenity Tokens, which are precisely recorded within the system. These tokens do not fluctuate arbitrarily in value but are tied to clearly defined mechanisms and rights.

### **Smart Contract Foundation & Transparency**

The Serenity Token is built on a smart contract, ensuring that:

- Every allocation, transfer, and model selection (HOLD/RESERVE) is technically traceable,
- Permanently recorded on the blockchain, and
- Verifiable at any time.

The process functions similarly to a digital notarial registration:

Who is invested, and to what extent, is not managed manually but securely represented through the smart contract – transparent, traceable, and tamper-proof.

## Token Hold & Reserve Strategies

After purchasing their Serenity Tokens, each investor can choose between two participation strategies. These two models form the foundation of the overall investment concept:

- **HOLD:** Participation in the Serenity Resort.
- **RESERVE:** Ongoing yields from the entire ecosystem.

The Reserve Model is described separately and in detail later in this Whitepaper; the focus here is on understanding the two fundamental approaches.

### **HOLD: Long-Term Participation in the Resort**

Under the HOLD model, the investor keeps their Serenity Tokens unchanged in their wallet.

#### **The tokens remain:**

- Tradable within the Serenity Exchange,
- Valid as proof of participation in the Serenity Resort,
- Directly linked to the long-term value development of the resort project.

The HOLD model focuses on allowing investors to participate in the real asset Serenity Resort. Once the resort is completed and begins generating operational profits, these profits are distributed proportionally to HOLD investors according to the defined distribution logic.

In this model, the SRT functions as a tokenized participation certificate: the investor foregoes early, daily, or monthly payouts in favor of long-term, asset-based profit participation in the physical core project.

## Token

### RESERVE: Yields from the Ecosystem

Under the RESERVE model, the investor intentionally chooses to transfer their Serenity Tokens into the Serenity Reserve System.

#### Technically, this means:

- The tokens are locked within a smart contract (“Reserve Status”).
- They are no longer tradable in this state.
- They serve exclusively to generate ongoing yields.
- They cannot be withdrawn from the reserve.

#### In return, the investor receives:

- Earlier and more frequent distributions,
- Earnings from all economic areas of the Serenity ecosystem (Resort, Trading, AI, E-Commerce, Exchange structures, Onboardings),
- A step-by-step fulfillment of their yield entitlement, credited in USDT to their balance.

#### Important:

In the RESERVE model, the token no longer represents a traditional share in the resort but functions as a digital claim to a defined overall return, which is fulfilled over time. The tokens themselves remain permanently locked in the reserve and are considered consumed once the full yield target has been reached. All payouts are made exclusively in USDT.

#### Additional Note:

When SRT tokens are sold via the internal Exchange, the number of tokens is transferred; however, if the new holder wishes to place these tokens into the Serenity Reserve, the original entry price of the first buyer is always used – not the price at which the tokens were purchased on the secondary market.

The reason for this is that Serenity can only work with the initial investment amount. **Therefore, if the new buyer deposits their tokens into the Serenity Reserve, only the original euro amount of the first investor is counted – not the price they themselves paid on the Exchange.**

# Token Price & Value Model

**The Serenity Token (SRT)** progresses through several clearly defined pricing phases during the official token offering. With each phase, the price increases step by step – a process explained in detail in the section Serenity Token Offering.

After completion of the 4th phase, the token price will be fixed and permanently stabilized at €0.16. From that point onward, the official value of the token will remain constant.

This mechanism fundamentally distinguishes the SRT from traditional volatile cryptocurrencies:

it is not a speculative market token whose price fluctuates based on supply and demand, but rather a blockchain-based digital investment certificate that clearly represents the invested euro amount.

The fixed price provides full transparency, long-term predictability, and a clear valuation basis – both for participation in the resort (Hold Model) and for placement into the Serenity Reserve.



## Token Summary

### The token is:

- A tokenized participation certificate,
- The digital proof of an investment in the Serenity Project,
- The foundation for two clearly defined participation models (HOLD & RESERVE),
- Technically secured through smart contracts, and

When depositing tokens purchased on the Exchange into the Reserve, the original euro entry price of the first investor always applies, as Serenity can only operate with this initial invested capital.

The Trading & Investment Division is one of the key financial drivers of the Serenity ecosystem. It utilizes professional, algorithmically supported capital management to generate stable and consistent returns, which are directly reinvested into the project's Treasury and Reserve Pools.

A defined portion of investor funds is allocated to an established and proven trading infrastructure. The primary focus lies on the Forex market, complemented by selected strategies in indices and cryptocurrencies. The trading team has a documented track record of profitable results, ensuring full transparency for investors.

Through this active capital management approach, the Serenity ecosystem is able to distribute returns early, long before the resort is fully operational. This division provides a stable and predictable income source, independent of the seasonal fluctuations of the resort business.



### **Core Aspects of the Division:**

- Professional Forex trading with a verified success record.
- Stable capital growth through the active management of a portion of investor funds.
- Transparent performance data accessible to investors at any time.

This division is therefore a central component for ensuring regular distributions and the long-term stability of the Serenity ecosystem.

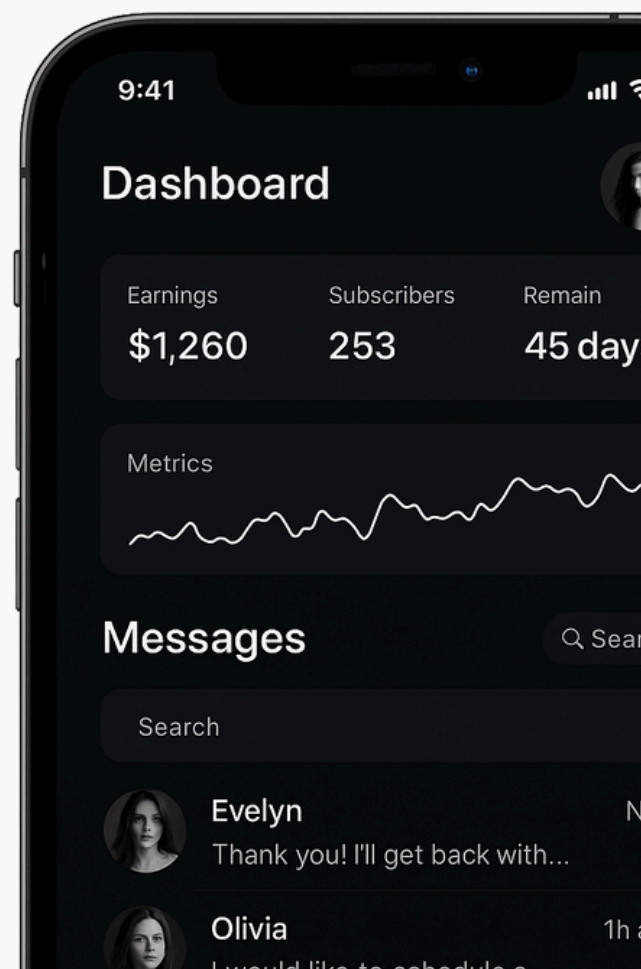

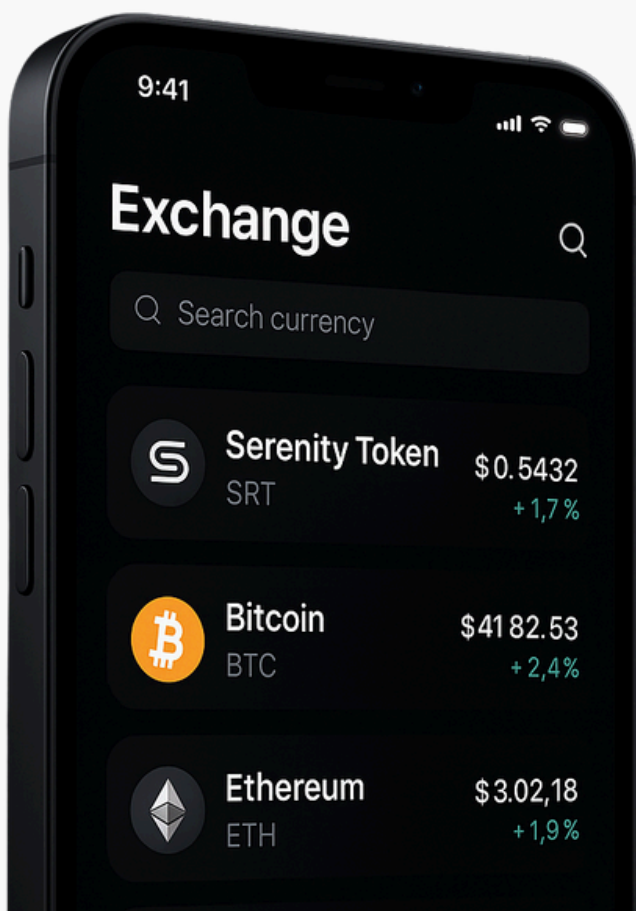

# Serenity Exchange

The Serenity Exchange is an internal, non-public trading platform developed specifically for the Serenity Project. Its primary purpose is the regulated trading of the Serenity Token (SRT) – particularly for investors in the Hold Model who wish to securely transfer or reassign their tokenized share of the resort.

Unlike public crypto exchanges, the Serenity Exchange is designed to support the trading of non-speculative tokens (such as the SRT) and will also offer this service for additional projects. The Serenity Token can only be traded at the official project price, processed transparently, stably, and securely through its underlying smart contract.

In addition to SRT, the Exchange also supports trading of selected cryptocurrencies such as BTC, ETH, and USDT. These markets operate freely as usual, while the SRT itself remains an investment certificate, not a speculative asset.



### Core Functions:

- SRT transfers at the official fixed price,
- Buying and selling of selected cryptocurrencies,
- Unified and stable execution via smart contract technology.

The Serenity Exchange therefore serves as the central, regulated trading infrastructure of the Serenity ecosystem – purpose-built for token-based ownership transfers within the project, while remaining flexible enough for standard crypto trading.

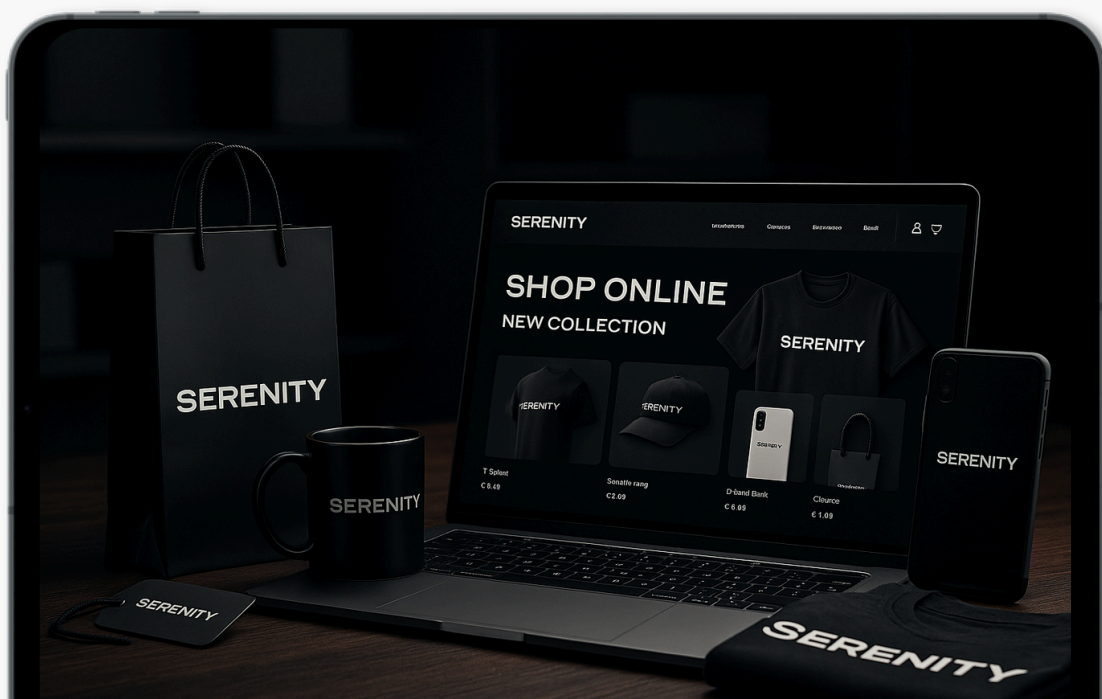

# Project Onboardings & Partnerships

The Project Onboardings & Partnerships division continuously expands the Serenity ecosystem by integrating additional projects, brands, and digital business models. External companies can leverage Serenity's existing infrastructure to launch their own token models, investment products, or digital platforms – fully integrated into Serenity's technological and financial architecture.

Serenity provides white-label solutions, full technical implementation, smart contract frameworks, and direct integration with the Serenity Exchange. This allows new projects to become instantly tradable, gain access to an existing investor base, and operate on a stable, verified infrastructure.

For the Serenity ecosystem, each onboarding generates fees, participation income, and additional transaction volume, creating another revenue stream that flows into the Treasury and Reserve Pools.

# Capital Allocation – Structured and Responsible Deployment of Resources

The allocation of funds within the Serenity Token Offering follows a transparent and well-defined structure plan. The objective is to utilize the invested capital efficiently and sustainably to ensure the long-term success of the Serenity ecosystem while minimizing investor risk.

The funds are distributed across six key areas, collectively forming the foundation for the operational management of the Serenity Resort, the technological realization of the digital platforms, and the overall stability of the ecosystem.

### **Serenity Resort Development – 45%**

The largest portion of the funds is directly allocated to the construction of the physical Serenity Resort.

This segment is essential to attract investors, guests, and strategic partners, driving both awareness and trust in the Serenity brand globally.

### **Team, Development & Founders – 10%**

A defined share of the funds supports the core operational team, including:

- Product and technical development,
- Project management,
- Resort planning and execution,
- Executive leadership and administration.

A 24-month vesting model ensures that the team remains committed to the project’s long-term success and fully aligned with investor interests.

## Use of Funds

### **Liquidity – 10%**

This portion serves as a financial stabilization buffer, particularly during the initial development phase.

It provides reserves for:

- Unforeseen expenses,
- Short-term liquidity needs,
- Operational reserves during the construction and development period.

By maintaining sufficient liquidity, Serenity ensures uninterrupted project progress and operational stability, even in the face of market fluctuations or temporary funding gaps.

### **Note on Flexibility of Fund Allocation**

The percentage allocations outlined above serve as a guideline for responsible fund management.

If unforeseen circumstances arise – such as regulatory changes, construction cost adjustments, or technical upgrades – a redistribution of funds may be necessary.

### **However, one principle remains absolute:**

Any reallocation will only occur in the best interest of investors and the sustainable success of the project.

### **All funds will always be used in a way that ensures:**

- Project completion remains secured,
- Financial stability is maintained, and
- Long-term investor returns are maximized.

This adaptive structure allows Serenity to respond flexibly and professionally to evolving market conditions – while maintaining full transparency, accountability, and strategic consistency.

# Serenity Commission Model

The Serenity Commission Model has been designed to reward partners fairly and sustainably for their active contribution to the project's growth. Instead of relying on traditional network marketing or complex multi-tier systems, Serenity introduces a transparent 3-level model that promotes genuine collaboration while maintaining long-term economic stability.

### Commission Structure

The model includes up to three levels with clearly defined percentages:

- Level 1 (Direct Referral): 30%
- Level 2: 15%
- Level 3: 5%

A commission is only generated when a level is actively filled. Unfilled levels do not create commission claims.

### Important:

Commissions are not deducted from the investor's contribution – they are generated additionally by the Serenity system.

### Credit to Serenity Reserve Balance

All earned commissions are not paid out immediately, but are instead fully credited to the Serenity Reserve Balance.

This balance grows with every successful referral and is gradually released as the ecosystem generates profits.

# The Serenity Reserve

The Serenity Reserve is the central mechanism through which investors receive ongoing returns, regular payouts, and predictable income flows. While the Serenity Token (SRT) represents the investor's share in the project, the Reserve converts that share into an active yield model.

### What is the Serenity Reserve?

The Serenity Reserve is a smart contract-based yield and distribution system into which investors can voluntarily deposit their Serenity Tokens. This deposit ("staking") transforms the tokens into a permanent claim on proportional profits generated across all divisions of the Serenity ecosystem:

- Serenity Resort
- Serenity Exchange
- AI & Digital Solutions
- E-Commerce & Branding Hub
- Trading & Investment Division
- Project Onboardings & Partner Projects

The **Serenity Reserve** is designed for investors who prefer early and ongoing payouts.

Tokens deposited into the Reserve are permanently locked and cannot be withdrawn or traded.

In return, Reserve investors receive distributions from all Serenity ecosystem business units starting from day one – until their full yield entitlement (up to 200% over time) has been paid out.

Once this total return has been fully distributed, the investment is considered completed.

Thus, the Serenity Reserve provides a clear, transparent, and accelerated path to returns, ideal for investors who prefer early cashflows rather than waiting for the resort's completion.

# HOLD or RESERVE

After purchasing Serenity Tokens, investors can choose between two clearly defined strategies: **HOLD or RESERVE**.

Both models serve different purposes and offer distinct advantages – depending on whether the investor seeks long-term participation in the resort or early returns from the entire Serenity ecosystem.

### **HOLD Model**

In the HOLD model, tokens remain fully liquid and represent the digital ownership share in the Serenity Resort.

Holders benefit directly from the resort's future profits once operations begin.

Unlike in the Reserve model, tokens under the HOLD strategy remain tradable and transferable at the official Serenity price.

### **Advantages of the HOLD Model**

- Direct participation in the Serenity Resort and its long-term stable cashflows.

# HOLD oder RESERVE

In the RESERVE model, tokens are permanently locked into the Reserve smart contract.

By doing so, they lose their function as a share certificate in the resort, but instead become a binding claim to earnings generated across all business areas of the Serenity ecosystem.

Even during the project's development phase, the first payouts begin – with a potential total return of up to 200% of the original deposit over time.

## Advantages of the RESERVE Model

- Early yield generation – payouts start during the project development phase.
- Earnings from the entire ecosystem, not just the resort.
- USDT payouts for maximum liquidity and flexibility.
- Predictable, continuous cashflow, up to 200% over time.
- Smart-contract-based, tamper-proof system without speculation risk.

## How Tokens Generate Returns

Depositing tokens into the Reserve converts them into an “income claim”, which is fully fulfilled over time.

The tokens themselves are not sold – they serve purely as a calculation basis, determining the investor's proportional share of the Serenity ecosystem's profits.

Payouts are made exclusively in USDT – fully liquid, stable, and directly withdrawable.

2. **Fairness & Stability:** Without a locking mechanism, an investor could collect returns, then reuse the same tokens for resort participation or sell them – a practice known as “system hopping.” The lock ensures fairness and long-term system integrity.
3. **Legal & Technical Clarity:** The smart contract permanently marks Reserve tokens as “RESERVE – permanently locked.” This creates clear regulatory and technical distinction within the Serenity ecosystem.

The Serenity Reserve offers several key benefits, making it one of the most attractive yield models within the Serenity ecosystem:

- **Early returns:** Payouts begin during the project development phase.

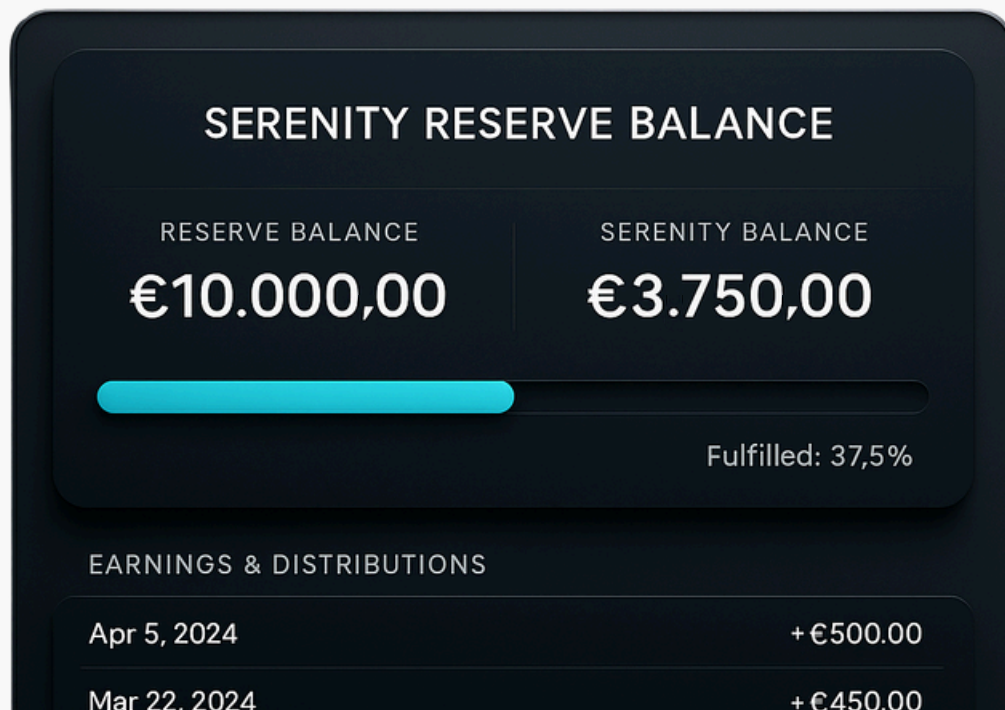

# The Investor Journey



## 1. Purchase of the Serenity Token

Investors purchase their Serenity Tokens during the official Serenity Token Offering. The token price depends on the respective phase of the offering.



## 2. Selection of the Investment Strategy

After the purchase, investors can decide at any time how they want to use their tokens.

The decision does not have to be made immediately.

- **HOLD:** Participation in the Serenity Resort and the entire ecosystem, with distributions primarily after the resort starts operations.
- **RESERVE:** Immediate deposit into the Serenity Reserve smart contract, with early and continuous returns from all ecosystem sectors.



## 3. Automated Allocation in the Dashboard

After purchase, all acquired tokens are initially displayed in the personal wallet. The investor can decide at any time whether to:

- continue holding them (HOLD), or
- permanently deposit them in the Serenity Reserve (RESERVE).

Trading Serenity Tokens (SRT) on the internal Serenity Exchange allows investors to purchase tokens already in circulation from other token holders. This secondary market creates flexibility and facilitates easier access to the Serenity ecosystem.

However, it is crucial to understand the following mechanism – especially in relation to the Serenity Reserve Model.

### **Reserve Deposits Are Always Based on the Original Investment Value**

Tokens purchased via the Exchange can, of course, be deposited into the Serenity Reserve. However, their valuation is not based on the price paid by the new buyer, but solely on the original euro investment made by the first investor during the official offering.

### **This Mechanism Ensures:**

- Fairness for all investors,
- Stability in Reserve calculations,

### Example for Clarification

- The first investor buys tokens at €0.10 → total investment €10,000.
- A new buyer later purchases the same tokens on the Exchange at €0.16.
- For the Serenity Reserve, only the original €10,000 is counted,
- as this is the actual amount that flowed into the Serenity Project.

### Transparency Through Smart Contract and Clear System Logic

All transactions – both purchases and transfers – are recorded on the blockchain, making it fully traceable:

### **Q1/Q2 2026 – Project Launch & Early Investor Round**
